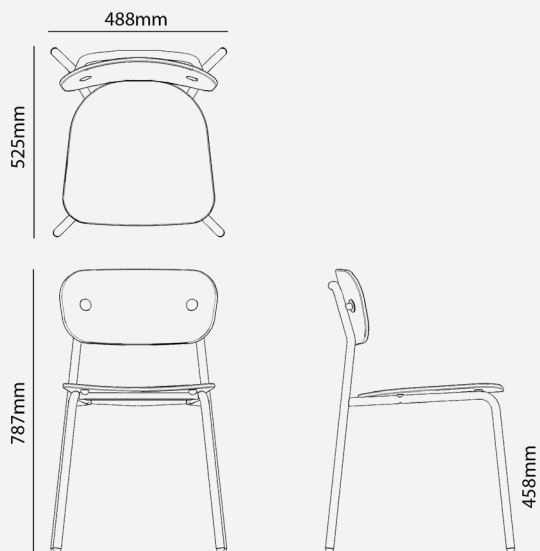

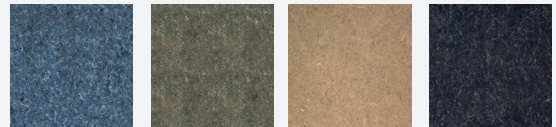

WATERRESISTANCE

The seating of the Rebel chair is made of recycled textiles and biological fibres in combination with a biodegradable matrix. The compression moulding makes the seat a solid material. The material is splash waterproof.

AND CLEANING

For the cleaning of the surfaces, use a light-moist cotton or microfibre cloth. Then carefully wipe off and rub with a clean dry cotton cloth. or make use of a feather wispher against dustgathering. This should be done regularly as dust can gather on the seating. To clean a specific stain we recommend intervening immediately and using an organic solvent (ex. trichloroethyle- ne). Do not use abrasive sponges as they may felt the product surface. Avoid using acidic products, solvents and products containing ammonia. Periodic and correct maintenance allow the product to keep its original aspect and lengthen the duration of its performance.
